**JUDGMENT OF DISSOLUTION OF MARRIAGE**

Now on this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, whereupon this cause coming on regularly to be heard and being ready for trial, the Petitioner submitted this cause to the court upon the pleadings and proof. Petitioner appeared in person, pro se. Respondent appeared in person, pro se. The Court took up for hearing the Petition for Dissolution of Marriage, witnesses were sworn, evidence adduced and the parties rested.

On the evidence adduced the Court finds as follows:

1. Petitioner has been a resident of the State of Missouri for more than ninety (90) days next preceding the filing of this action, currently living at 123 Main, Kahoka, MO 11111.

2. Respondent has been a resident of the State of Missouri for more than ninety (90) days next preceding the filing of this action, currently living at 321 Main St., Kahoka, MO 11111.

3. More than thirty (30) days have elapsed since the filing of this action.

4. A verified Entry of Appearance was filed by the respondent on January 25, 2008.

5. Neither Petitioner nor Respondent is a member of the armed forces of the United States of America and thus neither is eligible for the privileges and immunities of the Soldier's and Sailor's Relief Act.

6. Petitioner's Social Security number 111-11-1111.

7. Respondent's Social Security number is 222-22-2222.

8. Petitioner and Respondent were married on June 10, 2003, in St. Louis County, MO, and said marriage is registered in that county.

9. Petitioner and Respondent separated on or about January 1, 2008.

10. There is no reasonable likelihood that the marriage of the parties can be preserved and; therefore, the marriage is irretrievably broken.

11. Jane Doe is not now pregnant.

12. There are 2 minor children born or adopted of the marriage.

13. The children's names, dates of birth and Social Security numbers

are:

14. The children have resided in Missouri for more than six months immediately preceding the filing of this action and; therefore, Missouri is the home state.

15. It is in the best interests of the minor children for custody and parenting time to as set forth in the parties' Joint Proposed Parenting Plan. All of the terms of the parties' Joint Proposed Parenting Plan are in the best interest of the minor children.

16. The presumed child support amount of \$695.00 as determined by Supreme Court Rule 88.01 and Form 14 is rebutted as unjust or inappropriate under the circumstances of this case because the children will be spending an equal amount of time with each parent.

17. It is in the best interest of the minor children for Petitioner to pay to Respondent child support in the amount of \$500.00 per month payable through the Missouri Division of Family Support.

18. There is no marital property nor any marital debts for the Court to divide.

19. Neither Petitioner nor Respondent are in need of nor entitled to separate maintenance.

20. Wife's former name is Roe. The restoration of her former name to her would not adversely affect any of her creditors or any other person.

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED AS FOLLOWS:**

- A. The marriage of John Ray Doe and Jane Sue Doe is dissolved.
- B. Each party is awarded all personal property and personal effects in his or her possession on date of trial.

C. Neither Petitioner nor Respondent is ordered to pay separate maintenance to the other and this order is non-modifiable.

D. The Parenting Plan attached hereto is incorporated into and made a part of this order as if each term of the Parenting Plan were fully set forth herein.

E. Petitioner is ordered to pay child support to Respondent in the amount of \$500.00 per month payable through the Missouri Family Support Division.

F. Neither party is awarded attorney fees.

G. Costs are assessed to Petitioner.

F. Wife's name is hereby changed to her former name of Jane Sue Roe.
